CLASSROOM GRANTS: These competitive grants support classroom-based projects in Teton County School District #1, which are not covered by public funding. Grantees are selected based on the number of students impacted, the potential for long-term benefit, and fulfillment of a recognized unmet need.

STUDENT ACTIVITY FUNDS: This program supports a number of extra-curricular and academic activities that require private funding to continue. This includes Speech and Debate, National History Day, Model UN, Robotics, We the People, and others, each of which provides unique academic and leadership opportunities to students.

HEALTHY MEALS: This program ensures that every student receives nutritious, affordable meals, including fresh fruits and vegetables. It provides free meals for students who do not qualify for federal free or reduced cost lunch programs, but cannot afford their meals. It also supports the Munger Market program, which teaches students how to select healthy foods and provides weekend meal support.
